PAY SCALE FOR APSU, TANDEM AND VMIAC REGISTERS

Participation Remuneration Rates for the Lived and Living Experience Registers

This pay scale was originally co-developed by Tandem, the Victorian Mental Illness Awareness Council (VMIAC) and the Department of Health in March 2022. It outlines the levels of engagement and applicable rates for remunerating people with lived and living experience (LLE) via the peak bodies' registers.

This pay scale is an adaptation of the IAP2 Spectrum for Public Participation¹, the Mental Health Lived Experience Engagement Framework², and the Department of Premier and Cabinet Appointment and Remuneration Guidelines (Schedules B & C)³. It reflects contemporary Australian and internationally accepted understanding of public participation and engagement continua.

The Registers have oversight for paid activities. Non-paid activities may be promoted through the peaks' membership and community networks.

This document is a living document and will be regularly updated.
